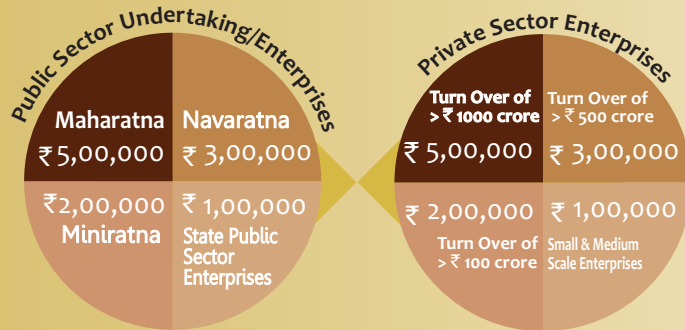
Monetary or intangible gains (nonmonetary gains) for CSF Members
