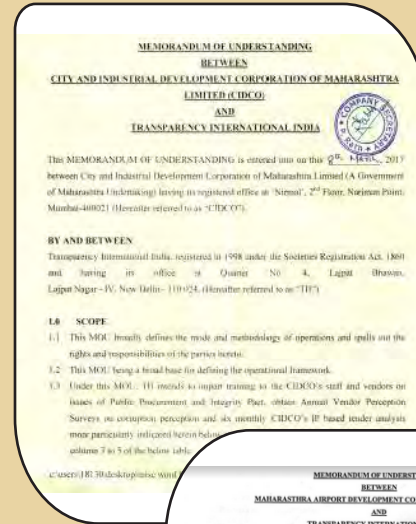

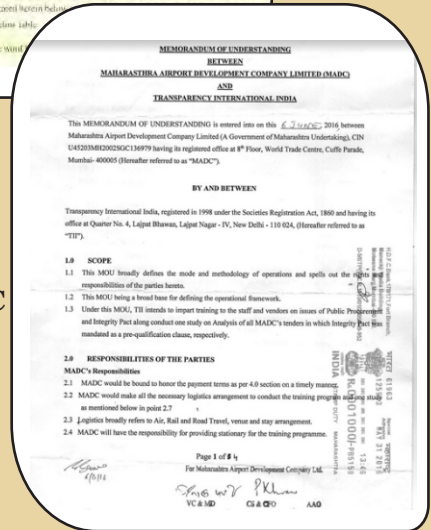

About the Training Program

TII has been providing training on Integrity Pact and Public procurement since the past five years. In the initial period the training was centralized and held in New Delhi where representatives of the Public Sector Undertakings attended the program. However, it was realized that TII needs to reach out to PSU's relevant staff who could not travel and attend the centralized training programs.

The flexible training module has been designed after consultation with experts. The training modules have been designed to capture all the norms that a PSU needs to follow in carrying out a tender, possible negotiations and norms to be followed for adoption of Integrity Pact. Integrity Pact is a special focus in these training program and emphasis is made on the role of independent monitors who act as a first line of audit of the tenders coming under the gambit of Integrity Pact. Further, with Integrity Pact contractors and concern third party have a well chalked out grievance redressal mechanisms which is not popular. Through the training all these aspects of Integrity Pact are propagated
