EDITORIAL

Compulsion or Design

The political class has not been charitable to any reform that impinges on their privileges. It has strongly and unanimously opposed the decision of the Supreme Court that had mandated that the candidates contesting elections must give their background with regard to education, criminal cases pending against them, and the assets and liabilities. It has not yet taken a categorical stand on the exclusion from candidature of those involved in criminal cases, especially the heinous ones, if the charge sheet has been submitted six months before the announcement of elections. It was again the apex court that had decided that once convicted, the legislator has to relinquish his seat. It was contrary to stipulation that permitted the finality of appeals in higher courts by which time the person had completed his tenure. Recently the Chief justice of India had indicated that there must be an evaluation of the reality check in terms of the manifestos released at the time of elections when the moon is promised for all. There has been no strict scrutiny of the election expenses, most of them by-passing the limits. The class is averse to the regime of the Right to Information Act.

to implement the Lokpal Act 2011 thus making the institution operational. The Act was passed after a nation-wide protest movement protest against corruption. It was then considered a singular victory of the civil society that had its say. There was a big fanfare with regard to achievement that was celebrated all over the country. It was the culmination of the recommendations of the Santhanam Committee during the mid-sixties. The tragedy is that even those who had taken part in the movement and claimed to have scored against the government are again playing fugitive in seeking its actualization.

However, the seed planted has not ripened as the institution is yet an aspiration. The only

hurdle, legally and technically, is the nonavailability of the Leader of Opposition, required for appointment of the Lokpal, as no party could secure sufficient seats in the legislature to qualify as such. This has continued since the general elections. But surely remedy is available through an amendment in law which should not be problem with massive majority of the ruling party. It is a step that would not elicit an opposition from any quarter as all political parties are publicly committed to deal with the menace of corruption. Consensus often happens in seeking privileges, and other issues like raising the eligibility income of the 'creamy layer' to a substantial amount, a move that no party dare oppose for fear of a reaction.

Till the stalemate is resolved, the benefits of the Act shall not be available. It has become a dead letter right at its inception, a tragedy of sorts, and a sad case of a child decapitated at birth, even though it can be resuscitated with little effort if there is a strong will. But if the doable is avoided, then one has a reason to suspect the intention of ignoring law that exists but is suffocated. It is a case of lawcide (apology for coining a word). And since the promise of law is denied for the last six years, it shall introduce forgetfulness. The civil society is quiet having achieved it, the government is finding an alibi for postponement, and public in general, though disillusioned, shall accept the 'new normal' and become apathetic and cynical.

It is classic case of 'design' camouflaging the 'compulsion'.
